Dr. Leigh Goodson reported that she had recently toured Mayo at the Wilson campus with Dr. Ballard. She expressed appreciation to staff who were working to get the school up and running. She stated that parking issues had been resolved.

Dr. Ballard stated that he had made opening remarks at the state PTA convention that was held during the previous week.

Dr. Ballard announced that Deputy Superintendent Mr. Millard House would be leaving the District for a position with the Charlotte Mecklenburg school district in North Carolina. After several comments from Mr. House, Dr. Ballard expressed appreciation for Mr. House's contributions and dedication to the District.
