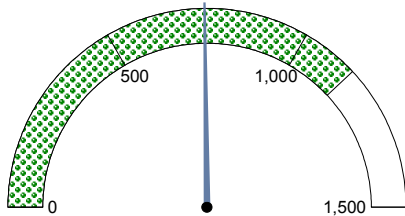


## EAST CENTRAL HS

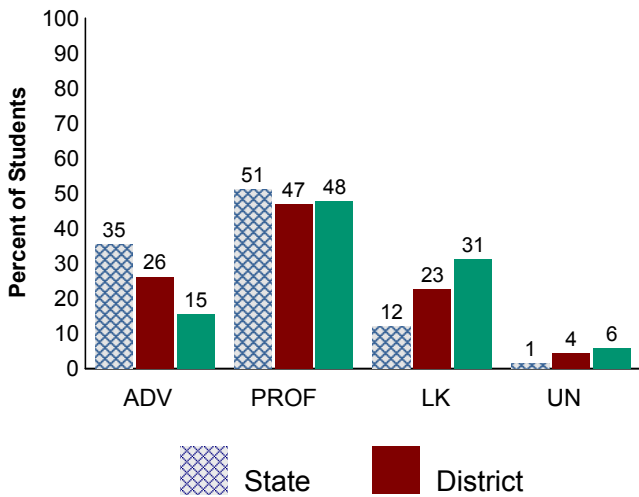

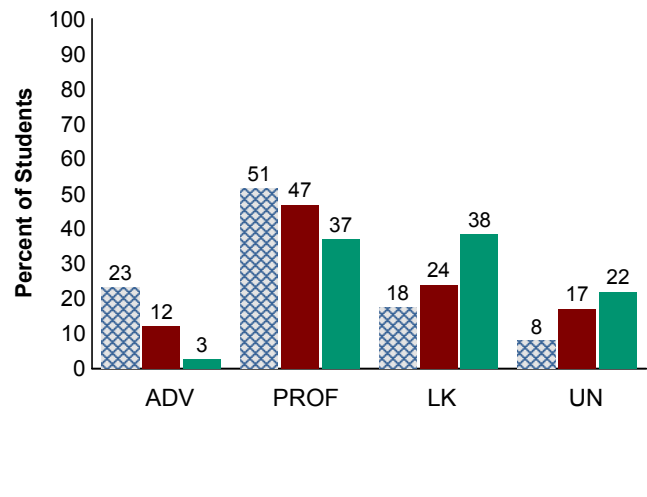
**State and District English II Results**

All Students Tested



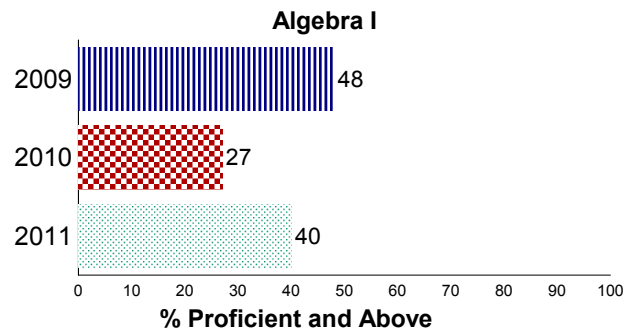
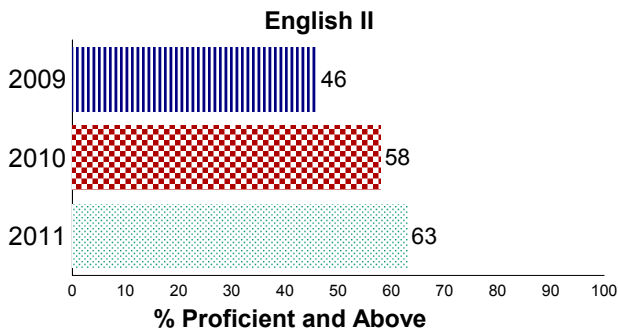
**State and District Algebra I Results**
