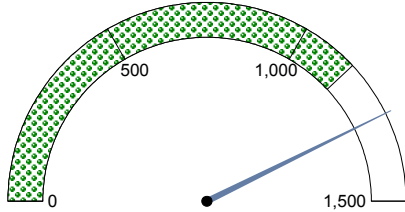


GRISSOM ES**No Child Left Behind Act Annual Report Card 2010-2011****Academic Performance Index (API) and Accountability Data**

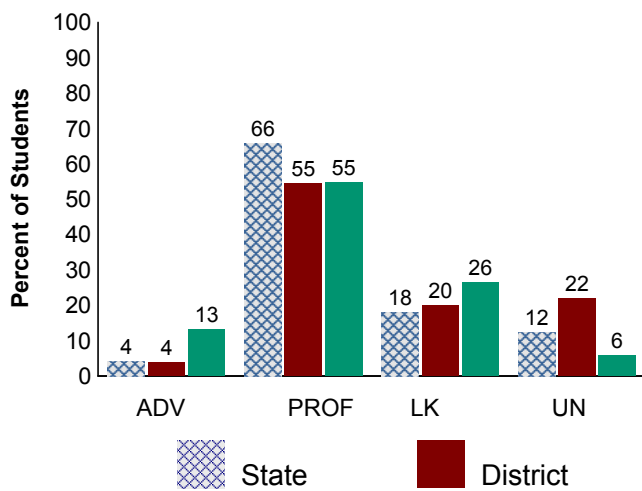

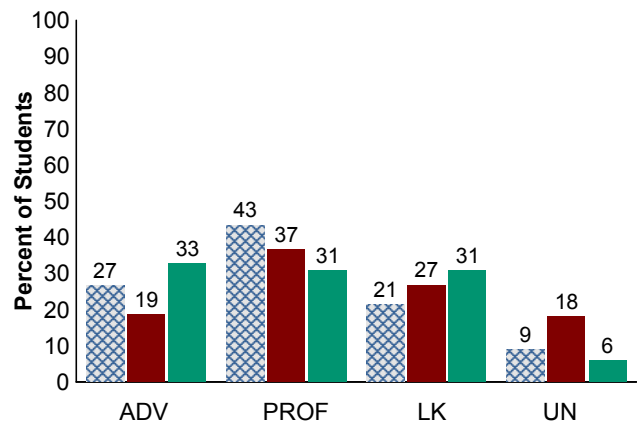
State and District Reading Results

State and District Math Results

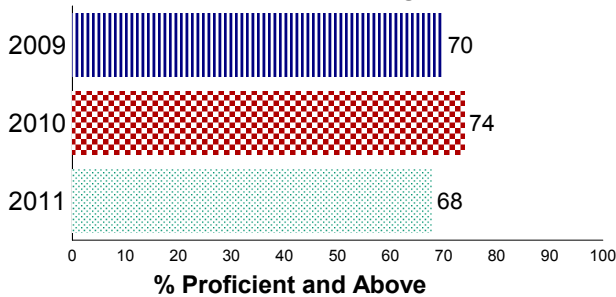

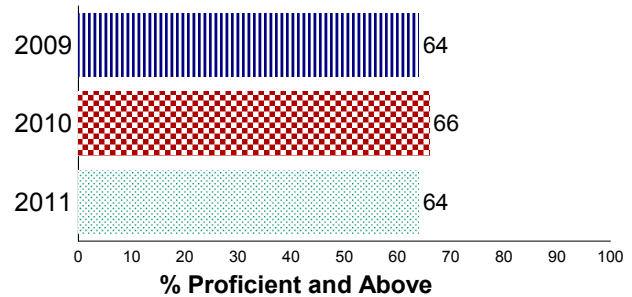

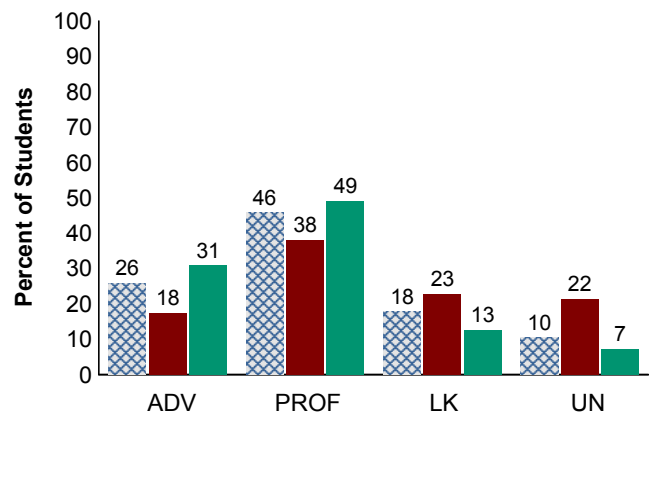
State and District Reading Results

State and District Math Results

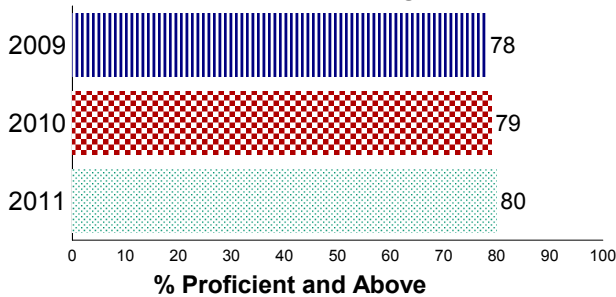

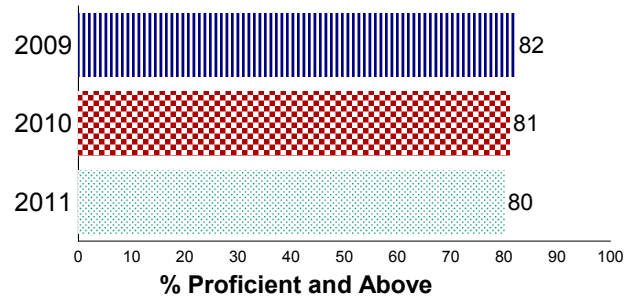

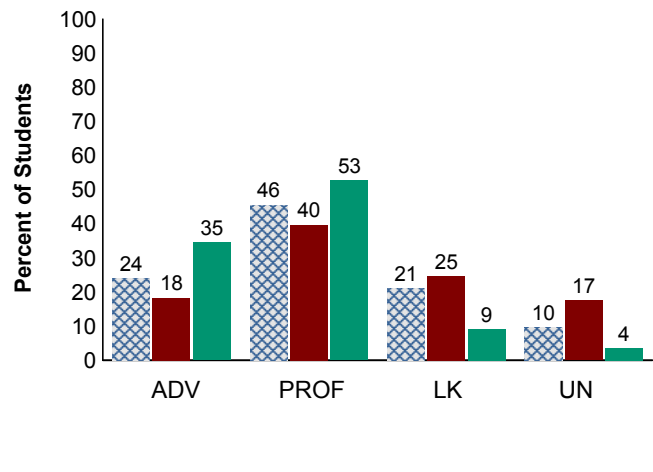
State and District Reading Results

State and District Math Results

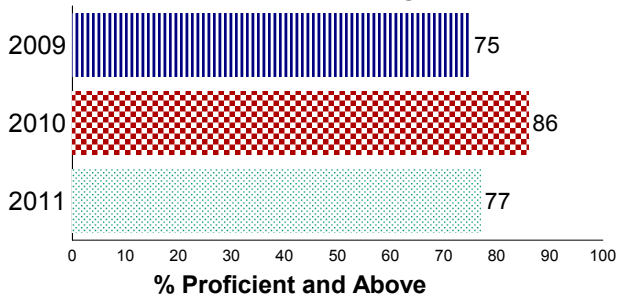

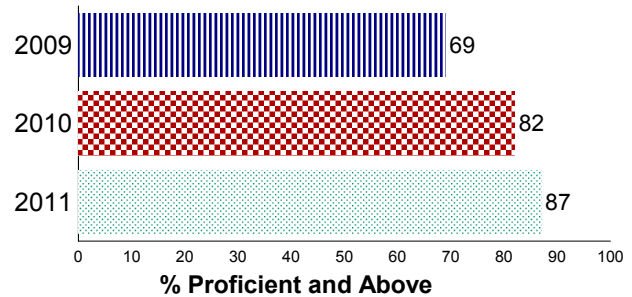
