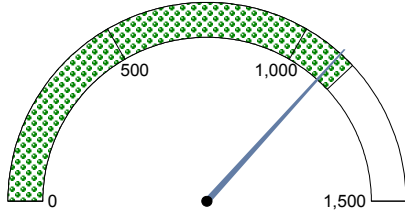


**KEY ES****No Child Left Behind Act Annual Report Card 2010-2011****Academic Performance Index (API) and Accountability Data**

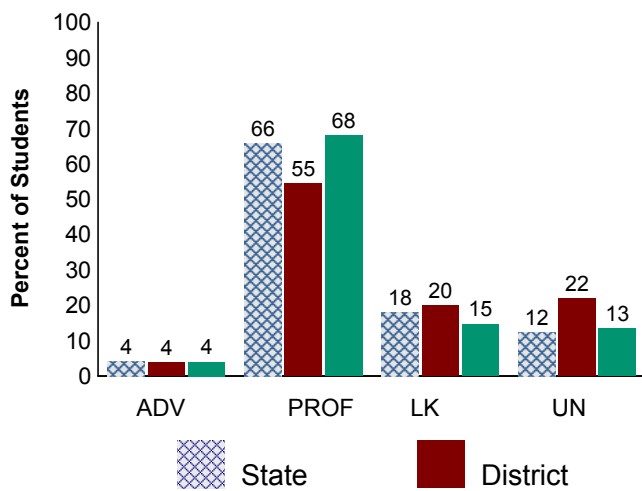

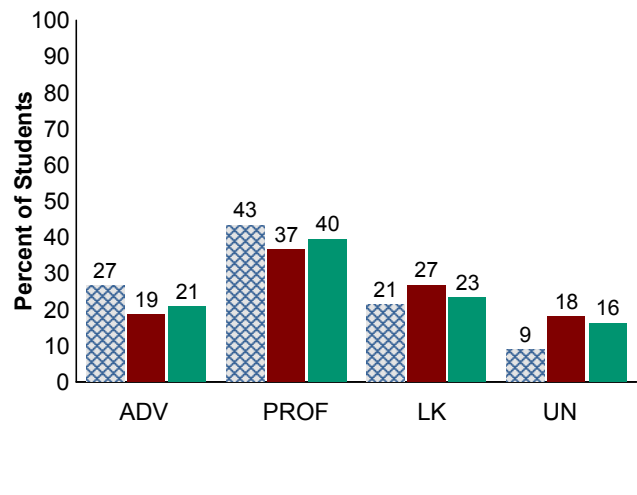
**State and District Reading Results**

**State and District Math Results**

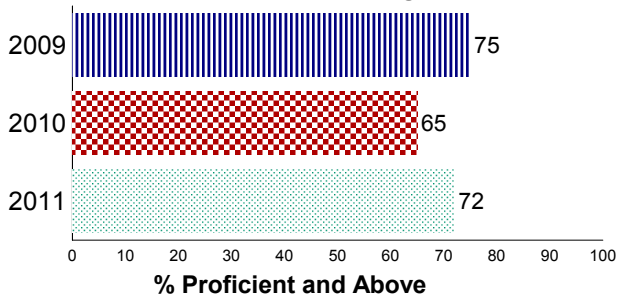

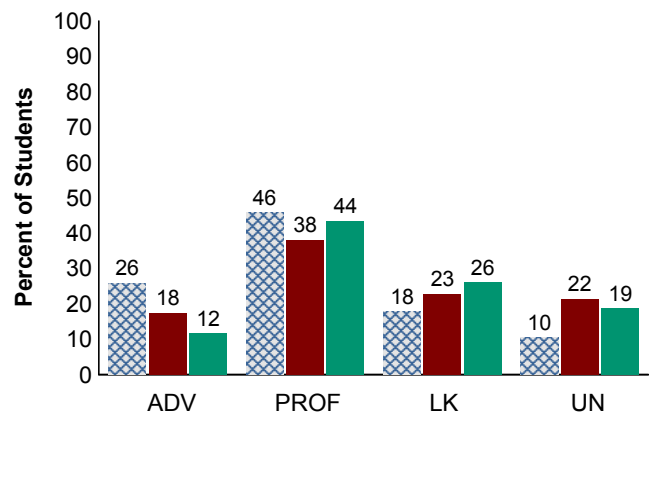

**State and District Math Results**

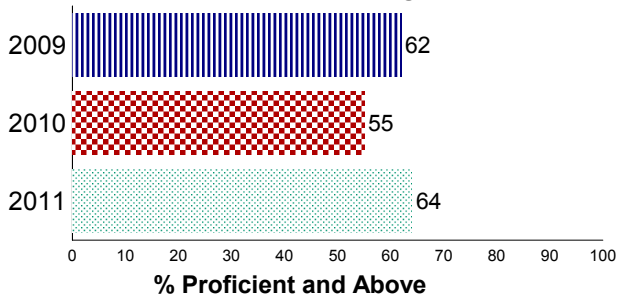

**State and District Math Results**

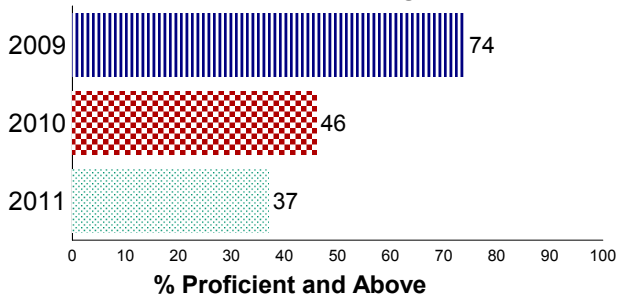

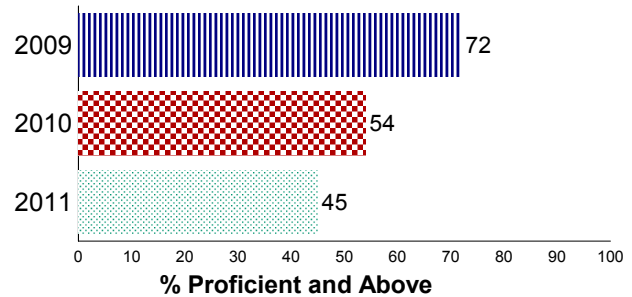
