Superintendent Gist encouraged all to take a moment of silence in remembrance of the 26th anniversary of the bombing of the Alfred Murrah building in Oklahoma City and the loss of 168 Oklahomans.

Dr. Gist also announced the launching of the Tulsa NextGen Externship program in collaboration with Senator Kevin Matthews and the Tulsa Regional Chamber that was created to ensure underrepresented students, particularly African American students, are connected to business leaders and career opportunities.

In light of extraordinarily difficult and violent national events, Dr. Gist reminded listeners of the Unit T-Town pledge of solidarity that Tulsa Public Schools created in July of 2016 in partnership with the Tulsa Police Department. The pledge that is hanging in the entryway of the Education Service Center serves as a reminder of the commitment and desire of the district and community for a stronger, better, brighter future for Tulsa students.
