Oklahoma. Whereas, 63 Oklahoma Statutes Section 683 et seq., the "Emergency Management Act of 2003", authorize this Agreement and each party in securing the benefits of mutual aid in the protection of life, public safety, and property from an emergency, major disaster, or other crisis.

Dr. Gist introduced Chris Hudgins to speak to items G.2 through G.10. Ms. Keller introduced Mr. John Huffines who spoke in support of items G.5, G.6, and G.10.

STAFF REPORT

There was no staff report.

BOARD MEMBER REPORTS

Ms. Jania Wester thanked the district leadership and district team for working so diligently to provide resources and a plan for educating students during this pandemic. She also referenced I the various mechanisms being used to keep families informed and urged families that are not receiving texts and calls to ensure that their contact information with the district is up to date. Ms. Wester also stated a desire for the board collectively and individually to find a vehicle for engagement and communication around topics not presented as agenda items.

Dr. Brian Hosmer thanked Jania Wester for her remarks. He also expressed his appreciation for district leadership and for our teachers during this uncertain and complex time. Dr. Hosmer spoke to the crisis and the disproportionate impact that is exacerbating existing inequities in our society. He concluded with a charge for all us to safeguard and adequately fund our public sphere that we all rely upon to include, education, healthcare system, etc

Ms. Schreiber echoed thanks to teachers, principals, and staff for setting up the distance learning that began last week with the distribution of resources. She mentioned her visit to some of the food distribution sites and that she was happy to see protective gear being worn and social distancing being practiced and that ultimately families were receiving food. She commended Jorge and his team and Hunger Free Oklahoma for their help as well and mentioned a local effort that is working to provide support for undocumented families and businesses.

Ms. Keller mentioned her agreement with the board member comments and referenced her own experience as a teacher this week launching virtual teaching of her students. She gave a shout

out to all district and state teachers for their herculean efforts at this time and reminded us of the teacher march to Oklahoma City just two years ago.

In addition, Dr. Gist shared updates about the engagement work and survey results informing district decisions regarding the Indian Education program.
